**Brief Description:** A very low risk event, suitable for people using a wheel chair. Meet outside the cafe at the northern end of the lake, unless other instructions are issued. Parking is available in a pay and display car park, adjacent to the cafe. Payment is by cash or card. The venue is also good for public transport including the 700 bus service, running between Brighton and Worthing. If SDOS are participating in an event hosted by other organisations, this risk assessment applies (and for that reason is extensive in its scope).

**Suggested clothing:** Warm, waterproof clothing depending on the weather conditions; strong footwear or wellington boots after rain. Some parts of the park can be very muddy after rain and standing water sometimes accumulates on one of the concrete paths near the lake.
